

# Autumn 2023 Newsletter

## **Community Asset Transfer**

The Community Asset Transfer was clearly dominating the time since the Summer Newsletter.

The Trustees used the summer to prepare the official Community Asset Transfer request of the Mill of Benholm from Aberdeenshire Council and all the needed supporting documents, including a business plan. The Board met with many local organisations to build the foundation for future collaboration and to evaluate the interest in the Mill of Benholm by the Third Sector. The response was strong and overwhelming, showing huge interest of all kinds of charity groups from the Scouts to Pillar Kincardine (Charity promoting positive mental health), from Milltown Community to the Guides, as well as Primary Schools, Aberdeenshire Community Mental Health Team and HM Coastguard to only mention a few. It laid bare the tremendous lack of sites, like the Mill of Benholm for groups and organisation to use in the South of Aberdeenshire.

On the 25<sup>th</sup> of August the completed Community Asset Transfer Request was submitted to Aberdeenshire Council, and has been validated on the 1<sup>st</sup> of September, starting the six months period for the Community Asset Transfer to reach the decision by Aberdeenshire Council in line with the Community Empowerment (Scotland) Act 2015.

In September the Board of MoBE negotiated a License to Work with Aberdeenshire Council to bring the electrical system back to safe working order in line with current regulations, install a new hot water cylinder and repair the plumbing for the toilets, and repair or replace the wastewater pumps, which are pumping the wastewater from the septic tanks to the reed bed for final filtration so that the toilets can be used again. Furthermore, the mill pond will be cleared of all excess vegetation, the access from the car park to the Mill will be made safe.

Volunteers will help to get the overgrowing vegetation under control and make the footpaths safe and accessible once again.

All this work is scheduled over the winter months while the Community Asset Transfer Request is going to the decision-making process.





Some of the Work has already started...

From September until the beginning of October the public consultation period for the Community Asset Transfer was open, which resulted in an overwhelming 63 supportive representations being submitted to Aberdeenshire Council. No objections have been submitted. Thank you to everyone!!

The Asset Transfer Steering Group of Aberdeenshire Council is evaluating all submitted and other available information, including the outcome of the public consultation and will complete a report either in support or opposition of the Community Asset Transfer, depending on their findings and the sustainability of our proposal. The Councillors of the Kincardine & Mearns Area Committee will vote on this report. If the report and vote are both in support of the transfer, the Mill of Benholm will finally be handed back to the community. If they are in disagreement, the request will be referred to the Business Services Committee for decision, and if the report and vote of the Area Committee are both opposing the request, the Community Asset Transfer would have been unsuccessful. MoBE would have the right to appeal against the decision in this case.



## **Conservation Plan**

Over the last few months Sonya Linskaill, RIAS Advanced Accredited Architect and Heritage Consultant, has worked on a Conservation Plan for the Mill of Benholm, funded by the Architectural Heritage Fund.



This conservation plan is the foundation for future restoration work at the Mill of Benholm, but it goes much further and is a wealth of information about the history of the Mill of Benholm and the heritage of our community. You can see the full Conservation Plan on

## Funding and Costs

The planned work during the License to Work period is expensive, legal fees for preparing the lease for the Mill Brae woods are high, insurance cover is needed, electricity will be used, only to name a few. The work needed to restore the Mill of Benholm, in particular the water infrastructure, after successfully taken ownership has been estimated with approximate £500,000. Also, professional advice will be needed from architects before restoration of a Grade A listed complex can be undertaken.

We have successfully applied for funding to cover some of the costs for the work during the License to Work Phase. The Kincardine & Mearns Area Committee will fund  $\pounds$ 5,000 towards the upgrading of the electrical installation and reinstating of the toilets. TAQA will pay from their Community Fund  $\pounds$ 900 towards the costs of clearing the mill pond of the excess vegetation, and COSS (Community Ownership Support Service) will help with  $\pounds$ 1,000 towards the legal costs of the lease for the Mill Brae Woods. And the SOLOS



Running Club St Cyrus has donated £200. We would like to thank Les Anderson for donating an outstanding amount of gardening tools and Mearns and Coastal Healthy Living Network (MCHLN) for passing some of their tools on.

Costs not entirely or not covered at all by the mentioned funders, will need to be paid for from our own funds, which are limited. Also, costs like insurance, website, printing, accountancy and other admin costs are not covered by funders, nevertheless the further we are progressing with the Community Asset Transfer the higher some of those cost will become. Just to enable our volunteers to work on site the required insurance is over \$800.

To prepare for the cost of Phase 1 of the restoration of the Mill of Benholm after MoBE has taken ownership of the Mill of Benholm, we have already submitted our Expression of Interest to the Community Ownership Fund and the UK Share Prosperity Fund successfully, and for the latter the full application has been submitted already. Expression of Interest has been submitted to the Aberdeenshire Place Based Investment



Programme. Further funding application to the Architectural Heritage Fund, Historic Environment Scotland, National Lottery Heritage Fund and other National Lottery funding programmes will be considered in due course.

## Volunteer Workdays and Work at the Mill of Benholm

After some delays due to adverse weather on the 18<sup>th</sup> of November volunteers started to work on site, and though it was a start, a lot was achieved on that day. We would like to thank the volunteers who showed up on this very grey and wet Saturday afternoon very much and hope even more will make it to our next Volunteer Workdays.





The next Volunteer Workday will be very different, as we are meeting from 1pm on Saturday the 9<sup>th</sup> of December in Benholm Kirk to decorate the Kirk for our fundraising event *Christmas in Benholm* on Sunday the 10<sup>th</sup> of December (details on page 8)

Furthermore, A.J. Carnegie Electrical Contractors, Montrose have already undertaken a check of the electrical installation and will carry out the needed repairs to make the electrical installation safe and bring it in line with current regulations over the next few days. This will enable Ferrier Pumps, Aberdeen to check the wastewater pumps and to repair and/or replace them if needed. George Milne, Plumber, Montrose will then in December repair the plumbing at the Mil of Benholm to bring the toilets back to working order.

Either in December or January the Sustainable Water Company, West Lothian, will clear the mill pond of all excess vegetation, as in the current state the mill pond would not be able to supply the waterwheel with the needed water.

## **Local Place Plan**

Aberdeenshire Council has approached us to develop a Local Place Plan with an initial meeting in December. This is our chance to shape the future of the Benholm Area. The first meeting with Council Officers will be in December.

## **BBC Radio Scotland**

Mark Stephen from BBC Radio Scotland's Out of Doors programme visited the Mill of Benholm in October and his interview with our trustees was broadcasted in two sections on the program on the 21<sup>st</sup> of October.

He is planning to come back in the future after the Community Asset Transfer of the site.
