Charitable purposes

To enhance the enjoyment of art and culture on site and in the environs of the Mill of Benholm. To promote and protect the natural heritage. To promote citizenship, community development, and to create volunteering opportunities for the benefit of the community of Benholm, the surrounding area and beyond by delivering a diverse variety of services and initiatives. To provide leisure and recreation facilities within the Mill, the surrounding woods and the wider environment, with the object of improving the health and wellbeing of the people of Benholm and the surrounding area. To advance education and learning by providing workshops, training sessions and courses on the site and in the surrounding woodland

Summary of the main activities in relation to these objects The Mill of Benholm is still owned by Aberdeenshire Council, a community asset transfer request has been submitted and was approved by Aberdeenshire Council in January 2024. The focus is now on completing the legal transfer of the site. In Autumn 2023 a License to Work was signed with Aberdeenshire Council to enable the Mill of Benholm Enterprise to prepare the Mill for ownership handover. Preparing fund raising events and submitting funding applications to be ready for the handover. 10 years pf hibernation has left the Mill in a sad state.
